Safeguarding during Coronavirus - update 30.03.2020

Cicely Haughton School are committed to maintaining safeguarding contact and support throughout the current crisis and have put many measures in place alongside guidance from the Government, Headteacher associations the local authority and Manor Hall Academy Trust.

It is important to note that the principles in <u>Keeping children safe in education (KCSIE)</u> and this guidance continue to apply, as does current advice contained in the school's <u>safequarding policy</u> unless otherwise amended here.

The most important message in the current circumstance is:

STAY HOME, PROTECT THE NHS. SAVE LIVES.

When schools were told to close on March 23rd to all but a few children who were considered vulnerable or were children of Keyworkers, the school put in place:

- A risk assessed grouping system so that we could manage some pupils on site
- Regular safeguarding phone calls to parents
- Safe & Well visits on the most vulnerable pupils who were not in school
- A tracking system in school which monitors who has received calls and a procedure to escalate where no contact was made.
- Contingency plans for FSM including deliveries.
- Succession plan in place for SLT who are self- isolating or ill.

Following the Prime Minister's Statement where effectively he announced a "lockdown" period of 3 weeks for the country we revised our safeguarding plans. We have advised against all but absolutely essential pupils being on school premises in order to reduce the spread of the virus. We drew up a new raft of safeguarding measures.

- Class Teachers and support staff to contact all pupils on a regular basis at least every 5 days
- Still maintain the school as open to any Keyworker pupil who has no other adult at home to safeguard their child.
- Continue to track contacts made, and to escalate if pupil/ staff contact has not been made within 7 days.
- Continue to offer pupil support by telephone
- Update Carers and Parents of any new information or guidance by phone, school e-mail, dojo, school web-site or text (from teachers2parents application). Staff have been advised to prefix calls with 141 to ensure privacy and security.
- Update Social Workers of the contingency plan and any concerns.
- Continued food parcels for the most vulnerable pupils and vouchers for the FSM cohort

Educational Offer

Each student has been provided with bespoke online and physical learning activities. These are updated when required. Teachers are liaising with parents and pupils through Class Dojo and can use this to contact parents and carers and many will use their school email address as a contact platform - and to send work in electronic form.

Physical support

Pupils attending site have been risk assessed according to vulnerability, health and likelihood of requiring physical support. As such updated advice on use of physical support and appropriate PPE has been issued to staff.

The current policy is still active and applicable.

Recording and reporting safeguarding concerns

All safeguarding concerns can still be reported directly to the DSL and recorded via MyConcern.
